## I. <u>Graduate Assistantship funding (Grant Support Policy)</u> – Provost Joan Lorden

• Provost Lorden shared a PowerPoint presentation with the Council. This has also been shared with the Chancellor's Leadership Team.

- In 2003, there were 25 PhD graduate students per year. There were few assistantships and waivers. It's not really a waiver; the funding had to come from somewhere. The dollars were taken from tuition and enrollment funding.
- There is a patchwork of many types of support. We weren't creating positions for students but trying to find funding.
- Dr. Jay Raja went to all of the colleges with a series of recommendations. First, graduate students were classified into four categories of responsibility:
  - 1. Teaching Assistants Full Time TA's
  - 2. Research Assistants
  - 3. Instructional Assistants grading, record keeping, etc. (recommendation \$20/hour)
  - 4. Graduate Assistants various positions
- Each program should have a framework for what their programs need as far as student employment.
- We must be consistent across the board with compensating students with like tasks.
- Students fees are a challenge for us. The fees at UNC Charlotte are higher than any other university in the UNC System. It's the biggest source of complaint from students. If we covered ENT/Health Services fees, it would be close to \$800 per year.

Dean Reynolds communicated that when the Graduate Council was first established, CLAS had and still has such a diversity in disciplines, that it was allowed so that representation was included for the Sciences, Humanities and Liberal Arts studies. With the pending review of possibly restructuring the college, this may be changed in the near future. The Graduate Council would need to make a proposal to the FEC (Faculty Executive Council) for any change to this body.

### 2. Dalton

- Integrating into an R1 university and mapping out moving forward
- The Graduate Council should be allowed to weigh in on 50.5 (Tuition Remission for Graduate Students Supported by Sponsored Awards). We need to understand our role and how it is being interpreted. The Graduate School has researched how other universities are interpreting the policy.
