## I. Report of the Chair – Dr. David Dalton

Chair Dalton opened the meeting with a welcome.

## II. Report of the Graduate School Dean – Dr. Tom Reynolds

**Enrollment Update:** Dean Reynolds commended the Council and their colleagues for the hard work in getting new and continuing students enrolled. At census, the university reported 30,448 students with a record breaking 6,332 graduate students.

**Faculty Awards:** Reynolds reminded Council of the upcoming faculty competitions that the Graduate School manages. Please encourage your colleagues to nominate candidates.

### III. **Discussion Topics**

#### A. Proposed Modifications to the GA Handbook – Johnna Watson, Graduate School

The Graduate Student Funding Workgroup, made up of Associate Deans, would bring recommendations to the Council relating to the eligibility to hold a graduate assistantship.

Full time enrollment is nine (9) Credit Hours or enrolling in 9999/7999 or 9998/7998 will push a graduate student to full time.

This amendment will allow a graduate student to hold a graduate assistantship with less than 9 hours, 20 hours of work per week or 6 hours in the summer. The GPSG (Graduate & Professional Student Government) organization overwhelmingly opposes linking the hours of enrollment to a graduate assistantship.

Graduate students can work up to 40 hours a week in the summer (summer internships), students have to be registered for classes in the fall semester.

Pinku Mukherjee, Associate Dean, CLAS, was highly in favor of this amendment because CLAS has a lot of Master's level students who would not be eligible to receive any kind of funding without this amendment because many programs do not offer full-time enrollment.

**Purpose:** Part of this amendment is to encourage students to make timely progress toward degree completion. Also, it allows some programs to offer funding for part time enrollment, (i.e, funding students in their last semester).

Chair Dalton asked the Council to discuss this proposal with their programs. He will also reach out to the Graduate Program Directors and ask them to communicate this with their Associate Deans and be ready to discuss at the October 5, 2021 Graduate Council meeting.

Lai made a motion to approve pending revisions with a second from Canevello. The motion was unanimously approved.

G. MSRE 6242 – Asset Management

1. Revise to include the graduate grading scale (page 2).
2. Replace dates for Week one, week two, etc., for modules.
3. The syllabus mentions a participation grade under "Code of Conduct", but participation is not included under "Grading and Exams" or "Course Structure"
4. Please include the syllabus for the cross-listed UG course ECGR 4105

Canevello made a motion to approve pending revisions with a second from Morse. The motion was unanimously approved.

#### H. MSRE 6245 – Real Estate Market Analysis

2. Description is missing how frequently this will be offered.
3. Unclear how 1.5 credit hours aligns with meeting weekly for 3 hours.
4. If cross-listed with an UG course, please include the UG syllabus.

Canevello made a motion to approve pending revisions with a second from Morse. The motion was unanimously approved.

#### I. MSRE 6310 – Land Use Policy

Wright did not attend.

The Council discussed the proposal and requested the following revisions to the syllabus:

1. Please revise to include a graduate grading scale (page 1).
2. Replace dates for course outline to (Week one, Week two, etc).
3. Proposal states offering in Fall 2022, but syllabus states spring 2022.
4. There are some inconsistencies in the syllabus - e.g., the outline refers to quizzes and assignments, but does not provide dates for these components. Quizzes are not listed under "grading and assignments" and only one assignment is listed.
5. The acceptable number of absences should be listed, given that attendance and participation are factored into grade.
6. If cross-listed with an UG course, please include the UG syllabus.

Morse made a motion to approve pending revisions with a second from Canevello. The motion was unanimously approved.

J. Master of Science in Real Estate, Graduate Program Revision

IV. Other Business


Lachance asked if syllabi should include allowances for COVID. Chair Dalton to reach out to Legal Affairs.
