The Faculty Council meeting began at 1:00 P.M.

- 1. Minutes of the previous meeting of the Faculty Council. Discussion of the minutes for the February 14, 2019 meeting generated no comments. Marks made a motion to approve and Dixon-Brown seconded the motion. The minutes for the February 14, 2019 meeting were approved unanimously.
- 2. Motion to award degrees Spring 2019. Leeman said it comes as a motion from FEC. Rowan seconded the motion. <u>The motion to award degrees for Spring 2019 was approved unanimously.</u>
- **3. Proposed revision to the Standing Rules regarding part-time faculty participation.** Comes from Part-Time Faculty Committee. Leeman gave background. This revision is an attempt to involve part-time faculty in faculty governance. This is often difficult based on their part-time schedule. One aspect of the proposal is to have a full-time chair. Another aspect is to add one part-time faculty member to various other standing committees. A third element of the proposal just removes redundant language about the Faculty Welfare Committee. Discussion ensued. Smith moved to approve the revisions to the Standing Rules. Dixon-Brown seconded the motion. <u>The motion to approve revisions to the Standing Rules was approved unanimously</u>.
- 4. Proposed revision to Baccalaureate Degree Requirements regarding calculation of major and minor GPA. We do not have a policy in how to calculate major and minor GPA. What is before you is proposed policy. This Fall they setup a process that would count every course that could count into the GPA. What is being proposed here is to count only the courses that actually slot into the major. This will only pick up a course attempt that satisfies the major requirements. The other two revisions were cleanup language suggested by the Faculty Academic Policy and Standards Committee (FAPSC). Adding "if applicable" when talking about a minor (to show that a minor is not required) and removing language that failed to indicate online course offerings (to make clear that online UNC Charlotte courses are considered in residence coursework). Discussion of how this revision would affect the calculation of major GPA ensued. Olga Pogorelsky, Registrar's Office, added that the repeat policy would be followed.

Q: Gray asked if this means if a "C" were required, a "D" would not be counted in major GPA but would count in overall GPA. A: Yes.

Q: McGoff asked if this calculated major/minor GPA is posted outwardly or only used internally. A: Only internally.

Rowan moved to approve the revision to Baccalaureate Degree Requirements. Papanikolaou seconded the motion. <u>The motion to approve the revision to Baccalaureate Degree Requirements</u> was approved with one vote against.

- 5. Discussion Item: Academic Personnel Handbook Procedures, Section VI B. and C. Academic Personnel Review Process, Annual Review and Review for RPT, regarding Non-Tenure Track Faculty. Personnel policies have to go further up the line. This is a discussion item only. Currently, there is nothing in the policies regarding review, reappointment, and promotion procedures of nontenure track faculty. Approximately 25% of the faculty are non-tenure track faculty. Dean Johnson says this process is happening every year because the non-tenure track are on one-year contracts in his college, so it happens more often than tenure track. He added that he does not believe there needs to be a college review committee in addition to the departmental review committee. Ford-Eickhoff suggested removing one sentence, "While a favorable annual review does not guarantee on-going employment beyond the special faculty member's negotiated contract term, reappointment of Special Faculty is contingent on a favorable reappointment review" because the sentence conflates the annual review process with the reappointment review process. Leeman said while this language is redundant, this language comes over from Office of Legal Affairs policy. Troyer indicated she is worried about the amount of work of having both a department review committee and college review committee. She believes one or the other would be fine. Ford-Eickhoff agrees with Troyer about adding the flexibility of allowing either a department-level review or college-level review. Mostafavi said that he thought there should be faculty review at the department and college levels.
- 6. Discussion Item: Academic Personnel Handbook, Section VI A. Academic Personnel Review Process, Review of Teaching. This is a discussion item and another the Faculty Employment Status Committee (FESC) has been working on. It involves review of teaching: how teaching is evaluated and what goes into the evaluation. Second thing is looking at how student evaluations are conducted and trying to regularize those and require us to have good practices. The Center for Teaching and Learning (CTL) has already given feedback that the statement "if requested, the input of staff at Center for Teaching and Learning and others" should be removed as they are not part of the analytical review. Gray recommended adding language that instructors should leave the classroom while students are filling out evaluations. Ford-Eickhoff stated that the language "at least two peer reviews of different classes of new faculty" is not clear what it means. Gutierrez says they do not use the term "teaching portfolio" in her college. Leeman said a more common term for the teaching dossier could be used. Leeman said to send additional comments to him or to your FEC member.

7. Report of the Chancellor. Chancellor Dubois shared the following:

- Yesterday, we got the hotel conference center back in budget. We will break ground in April with March 2021 the goal.
- A successful legislative diner was held on February 26 in Raleigh. We talked about what is important to UNC Charlotte. Compensation for faculty and staff, carry forward money, capital money, etc.
- The Governor's budget is out. This gets the conversation started. It takes months for the budget to be worked out. Republicans lost their veto proof majorities. The Governor wants

an increase in teacher pay. There is a salary increase in the Governor's budget for all state employees of 1.5%, which is lower than we wanted. We are hoping for at least 2%.

- The national scandal about admissions prompts the question: Does our enrollment process have the necessary checks to ensure nothing like this can happen? We are confident, but looking into our processes. Any student athlete recruit that does not meet the minimum academic requirements has to be approved by me and then an academic plan is put in place.
- We are looking into having another exit out of the university onto Tryon that is not as affected by the light rail a right-turn exit only.
- We are working with a marketing firm out of Columbus, Ohio, called Superlative. They can help us market our University. They will get to know our campus, then tell us what everything is worth, so we can find ways to pursue commercial marketing opportunities. Naming rights on our new recreational center may be attractive.
- 8. Report of the Provost. None.
- 9. Report of the President-Elect. None.
- 10. Report of the President. We put out a call for nominations for the position of University Mediation Coordinator/Associate Faculty Ombuds. This is an important position for Faculty Governance. Please think about who among your colleagues may be interested. Please do not assume that someone else will find a nominee. The position has to be tenured associate or full professor.

11. New Business. None.
