I. Approval of the November 2, 2010 Meeting Minutes

Chair McGregor called the meeting to order.

Chair McGregor asked for a motion to approve the minutes of the November 2, 2010 meeting minutes. Chair McGregor submitted revisions to the minutes on page 2, Section V, 6th sentence: change the word minutes to proposal, Section VII, 2nd sentence, add Signal Processing after 4222 Multidimensional and add Multidimensional Signal Processing after 5222. There being no further comments, the Chair called for the motion to approve the minutes with the two revisions. Teng made the motion with a second from Schneider. The motion was approved unanimously.

II. Report of the Chair

Chair McGregor had one item to discuss which was procedural. If a graduate level course is established and Undergraduate students want to take the class, how is this done? A discussion took place and the Council decided that a long form would be required to establish a new Undergraduate course, but a short form could be used to cross list the Graduate Course to it. The Chair called for the motion to approve the procedure. Scheid made the motion with a second from Teng. The motion was approved unanimously.

III. Report of the Dean

- There will be a system-wide Graduate Council meeting in Chapel Hill on Friday, December 10. At that meeting our request to establish the PhD in Bioinformatics will be considered by the Council.
- New programs for next fall will include:

MA in Anthropology
Master in Fire Safety
Masters in Construction Management

Hopefully: Bioinformatics PhD PSM in Health Informatics

- 61 doctoral students are eligible to participate in the December Graduation Ceremony. (includes summer graduates 34 fall graduates 31 will participate in the ceremony) Still processing master's graduates so not sure of the numbers but 712 graduate students have applied to graduate for this fall compared to 420 in the fall 2009
- Next semester the Dean would like the Council to consider the issue of Graduate Program review at UNC Charlotte.
 - i. There isn't time to discuss the rationale of this proposal today except to say that presently UNC Charlotte is the only research university in North Carolina that doesn't engage in a regular, systematic review of its graduate programs.
 - ii. Although degree programs are carefully evaluated and reviewed at the time they are proposed, once they are approved, they may never be evaluated again.
 - iii. Since graduate programs are dynamic due to changes that occur as faculty come and go, student applicant pools increase or decline, and academic disciplines naturally evolve, it is important that all graduate degree programs should undergo evaluation by the University on a regular basis.
 - iv. Five of our doctoral programs were part of the NRC survey of the Research Doctorate that was recently completed and this review might serve as a model for graduate program assessment.

IV. Course and Curriculum Proposals:

a. <u>CSLG 10-25-10</u>: <u>Establishment of a Specialty in Addictions Counseling</u>
Chair McGregor called for the motion to consider. Schneider made the motion with a second from Scheid. A discussion took place and several questions were raised. Since there was no one in

attendance to field the questions Chair McGregor asked if the Council would like to defer approving for a re-write. The motion was made by Scheid and a second from Jones.

b. EDLD 10-19-10: Revised Graduate Certificate in School Leadership

Dawson Hancock and Delores Lee were present to represent the Ed Leadership department. Chair McGregor called for a motion to consider. Scheid made the motion with a second from Kulkarni.
