I. Report of the Chair - Chair Rob Roy McGregor

II. Report of the Dean – Dean Tom Reynolds

Dean Reynolds announced Faculty Council is taking nominations for the 2017-18
 Graduate Council Chair position and encouraged the Council to contact Lisa Walker to volunteer or nominate someone.

- Update on Graduate Applications: the number of applications submitted are down from 6,691 last year to 6,256 this year, but offers of admission are up from 3,259 last year to 3,865 this year.
- Federal Financial aid will no longer consider graduate students enrolled in three credit hours as half time. Graduate students are consider full time if they are taking nine credit hours and we have been allowed to roll-down in the past. Beginning this fall, to receive federal financial aid graduate students must enroll in a minimum of 4.5 credit hours, which realistically is 6-credit hours.

III. Graduate Faculty Membership Criteria - Rob Roy McGregor

<u>Physics & Optical Science</u>: A discussion took place and the Council agreed that this Graduate Faculty Membership Criteria did not match current guidelines.
