- **Council Review/Input:** Currently the Cato College of Education has seven "short form" • proposals for the Graduate Council Chair to approve in Curriculog. They would like to change graduate student teaching courses from three credit hours to variable credit, three to six credit hours. Justification offered; course loads vary (some have more required assignments) and with federal financial aid's new definition of half time this difference needs to be reflected. With no objections from the Council, Chair McGregor will approve.
