### I. Report of the Chair – Concepcion Godev

# II. Report of the Graduate School Dean – Katherine Hall-Hertel for Dean Reynolds

Reynolds explained the Administrator Review Process. In the past, administrators, including the Chancellor, Provost and Deans, had their annual evaluations shared automatically with constituents. Legal Affairs recently pointed out that this isn't legal unless the individual being evaluated waives his or her right to confidentiality. Academic Affairs is working on a policy but for now, it is up to the administrator to decide whether or not to share the review. Reynolds' evaluation has been posted on GPDnet.

What happens if Policy 50.5 goes away? Current funding supports about 700 students. Health insurance and tuition is covered; but does not include fees. It would be hard to support a new policy unless we are clear where the money for graduate student funding will come from. How will the new plan be phased in?
