## I. Report of the Chair

## III. Course and Curriculum Proposal

#### A. HIST 11-18-2015 Establishment of New Course HIST 6300

A discussion took place and the following comments were shared.

- o Change numbering to 6300 throughout (not numerically sequential).
- o Syllabus is for 6000 course, update syllabus for 6300 course.

### F. PHIL 11-10-2015 Replace one crs req. with another in MA in Ethics and Applied Philosophy

A discussion took place and the following revisions are requested:

- Page 2, under Add one course: with regards to this sentence, PHIL 6999 –
   Master's Research Paper (3 credit hours; may be repeated for credit with new
   material) the council would like clarification on the number of credit hours that
   can be earned.

- Page 8, under **Evaluation** delete the first sentence of the paragraph which reads, If a student receives a grade lower than a 'B' on the paper, she or he will be given an incomplete and asked to continue to work on the paper until it is of acceptable quality, and any comments regarding this extension process.
- Page 8, more clarification regarding evaluation of participation grade, oral
  presentation grade, and the grade of the paper itself, explicitly defining what A, B,
  C, and U work is.
- o Page 8, evaluating the oral defense should be in a different section.
- o Page 9, editorial correction, the last sentence is incomplete.
- o Include a library consult.

There being no further discussion a motion was made to defer this proposal back to the department pending additional information. The Graduate Council will review the revised proposal if received at the February 2, 2016 meeting. McGregor made the motion with a second from Hildreth. The motion was passed unanimously.

## G. SIS <u>02-05-2015</u> Changes to the MS in Information Technology

## J. WGST 11-9-2015 Course Numbers and Core Requirements

A discussion took place and the following revisions are requested:

- o Course numbering needs to be consistent.
- Suggest adding cross listing statements in the course description of the catalog for consistency.
- o Consider cross listing with History.
