I. Report of the Chair - Concepcion Godev

a. Approval of the February 4, 2025, meeting minutes

Chair Godev made a motion to vote on the February 4, 2025, meeting minutes as submitted. Montanaro made a motion to approve as submitted with a second from Xu. The motion was approved by a unanimous vote.

b. Updates from Chair Godev

i. Chair Godev reported that the seven items put forth in the revisions to the Graduate Faculty Bylaws were overwhelmingly approved by the graduate faculty. The vote required a response from 35% of the regular graduate faculty, and 312 of the 760 faculty members, or 41%, responded. Matt Wyse confirmed that the approval process is complete, and the new version of the bylaws will be posted to the website.

- ii. A new program, Master of Science in Artificial Intelligence, is being proposed. The proposal was not submitted in time to make the agenda for today's meeting, but there is a tight deadline of April 1, 2025, to get it approved, since this is the last date that the General Administration will consider a new program. Since the Graduate Council will not meet again before the deadline, Chair Godev asked the Council to review the proposal asynchronously. Chair Godev shared a Google folder with the Council containing 9 documents and asked them to review the documents and record their comments. The Council members need to vote on the proposal via a Google form link in the documents by March 21.
- iii. Chair Godev reported that there were 46 proposals in her queue requiring minor tweaks. She passed the proposals in lieu of having them reviewed by the entire council.
- iv. Chair Godev announced that she will be rolling out of her position as chair of the Graduate Council at the end of the semester. Nominations are being accepted for the next chair.

II. Report of the Dean - William Tolone

Dean Tolone thanked the Council for addressing the MS in Artificial Intelligence proposal. He said that this program will benefit AI as an initiative at the university. He also acknowledged that this has been a disruptive time in higher education, but UNC Charlotte is a resilient campus, and the Graduate School will continue to be proactive. He highlighted the work the Graduate School has done in finding funding for Fullbright Scholars.

III. Discussion Topics

a. Health Management and Policy

The Council reviewed the HMP Graduate Faculty Criteria document submitted by Michael Thompson. Dr. Thompson attended the meeting to answer questions. After discussing the document, the Council suggested a few corrections that Daniel Jones will summarize and send to Dr. Thompson. Allan moved to approve the document pending the corrections, which was seconded by Brown. The motion was passed unanimously.
